2. Selection of the Concept Plan under this EoI shall not confer any right, claim, or entitlement upon the selected applicant for award of any further work, consultancy, or contract related to the project.

1. PARTICIPATION FEE

- Applicant shall has to deposit a **non-refundable** participation fee of Rs. **1180/- (Rs. 1000/- + 18% GST extra)** through Demand Draft only in the name of “Chhattisgarh State Renewable Energy Development Agency (CREDA)” at Raipur.
- Application received without or with inadequate EoI participation fees shall be liable to be rejected.

2. CREDA RESERVES THE RIGHT

To reject or accept any or all EoI fully or partly without assigning any reason on the grounds considered advantageous to CREDA.

3. COMMUNICATIONS

- All the communication between applicant and CREDA shall be in writing. Notice sent by Fax or other electronic means shall be effective on confirmation of the transmission. Notice sent by registered post or speed post shall be effective of delivery or at expiry of normal delivery period as under taken by Postal Service.

- B.** Offers through Telegraph/Fax/Emails/Post/Courier or open offers etc. received shall be summarily rejected.
- C.** Nobody is authorized to receive or grant receipt for concept plan submission on behalf of CREDA. **Concept Plan received through any other means shall not be considered and shall be rejected.**

4. SUBMISSION OF DOCUMENTS

Documents should be submitted in prescribed manner in envelopes as follows:

- A. Main Envelope:** Main Envelope must enclose all relevant documents. Applicant Name, Address and status of firms should be clearly written on the main envelope. The EoI name with No. should be mentioned on the top of the envelope.
- B.** The applicant shall submit soft copies of designs & the mode shall be through CD/Pen drive. Intended applicant must not be black listed/debarred by any Central/State Govt. Organizations or Departments, PSUs or JVs.
- C.** In case of any dispute referred to the CEO, the decision of CEO CREDA, will be final and binding to all the applicants.
- D. The applicant/authorized signatory shall sign each page of the document of notice and Enclosures.**
- E.** Any information furnished by the applicant found to be incorrect either immediately or later, would render him liable to be debarred from the aforesaid work of CREDA.

5. JURISDICTION OF THE COURT

Any dispute arising out of the contract shall be subject to the jurisdiction of Hon'ble High Court of Chhattisgarh.
